Springbank Secondary College caters for students from 7-12. At the time of this report, the enrolment in 2024 is 229. Springbank Secondary College is classified as Category 4 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 4% Aboriginal students, 46% students with disabilities, 8% children/young people in care. Governing Council Report

The School Governing Council had a productive and impactful year, contributing to the ongoing growth and development of our school community. Leadership Transition

Policy Approvals

The council was actively involved in the review and approval of several key policies aimed at enhancing the school environment and student well-being. These included:

- Student Behaviour Management Policy ensuring a positive and supportive learning atmosphere.
- Yard Duty Policy enhancing student safety and supervision.
- Uniform Policy reinforcing the school's identity and dress code standards.
- Attendance Policy promoting regular attendance to support academic success.

Technology Integration

The council supported the school's direction in implementing **Chromebooks** as part of the Bring Your Own Device (BYOD) Policy. This initiative aims to enhance digital learning opportunities and ensure students are well-equipped for modern educational needs.

Financial Support and Fee Adjustments

To better support student learning outcomes, the council approved an **increase in Materials and Services charges**. This decision was made to ensure the school can provide the necessary resources and materials that contribute to a high-quality education for all students.

School Vision and Values

A significant milestone for the council this year was our involvement in **re-establishing the school's vision, values, and motto**. We are pleased to have played a role in shaping the guiding principles that will continue to drive the school's culture and future success.

We extend our gratitude to all council members, school staff, parents, and students for their ongoing support and contributions. We look forward to another year of progress and collaboration.




Performance Summary NAPLAN Proficiency





Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
